 - A. Bank Statement (Revenues)

A financial Report was presented by Mrs. Grecia Lucio.

As of February 1st 2023, the beginning balance was of \$3,672,764.07, a total of 18 Deposit/Credits in the amount of \$488,842.89, a total of 7 Withdrawals (checks)/Debit in the amount of \$12,410.62

The ending balance as of February 28th, 2023 is of \$4,155,363.25, interest incurred for the month was \$6,166.91. The reconciliation for the month of February was complete.

Attached is the Tax Assessors Report; total funds to entity for the month of February were \$409,017.10.

Total revenues to date for the fiscal year 22-23 are in the amount of \$3,898,429.92. The CCESD is currently at the end of the -2^{nd} quarter of the fiscal year.
