Meeting was called to order by Mr. Tapia at 1:33 p.m.

Quorum was established by four board members present. Mr. Eduardo Alvarez and Calixto Suarez absent.

Presentation of bank statement, revenues and payment of claims was presented by Mrs. Lucio. As of February 1, 2025 the beginning balance was of \$4,403,402.68 a total of 19 deposit/ credits in the amount of \$336,424.44, a total of 14 check/debit in the amount of \$52,376.79, total interest incurred for the month in the amount of \$7,007.04. Ending balance as of February 28, 2025 was in the mount of \$4,694,457.37 Total revenue for the month of Revenue for the month of February was in the amount of \$248,051.47. The reconciliation for the month was complete.

Presentation of payment of claims was presented by Mrs. Lucio

Mrs. Lucio stated that under supplies and equipment an expense for Jack Allens restaurant in the amount of \$657.25 for SAFE-D board member dinner, an expense for Razzoos Cajun Café SAFE-D board lunch in the amount of \$281.30, and the last expense for HEB in the amount of \$28.91.

Motion to acknowledge and approve items A., and B., made by Mrs. Meyn seconded by Mr. Perez.

Mrs. Lucio stated that she will be presenting all action items. She stated that Thomas Hushen and County Fire Marshal were in a meeting in reference to the Transmigrantes.

For the coordinator's reports, Mrs. Lucio stated that she made (1) over the counter withdrawal to reimburse Juan Martinez's SAFE-D conference meal perdiem in the amount of \$157.50. Mrs. Lucio sated that Mr. Tapia approved to proceed with over-the-counter withdrawals for items under \$500.00 dollars. She stated that all back up documentation for said withdrawals will be presented in each monthly meeting. Mrs. Lucio stated that this will avoid any inconveniences and will speed small reimbursement as such. End of report.

Mr. Lucio reported for the consultant, she stated that Mr. Hushen made contact with TCEQ and reported the illegal dumping site in the city of Los Fresnos. Mrs. Lucio then stated the County is currently under a 90 day burn ban commencing March 25, 2025 through June 23, 2025. The current burn ban may be extended beyond the initial 90-day period, or it could be shortened, depending on evolving conditions
